This has reference to the news article entitled "Semirara takes loss as exports halted" posted in Malaya Business Insight (Internet Edition) on July 23, 2015, which the Philippine Stock Exchange has requested Semirara Mining and Power Corporation (the "Company") to make a clarification and/or confirmation.
