We advise that Southwest Luzon Power Generation Corporation (SLPGC), a wholly owned subsidiary of Semirara Mining and Power Corporation has been issued Certificate of Compliance (COC) on March 1, 2018 by the Energy Regulatory Commission (COC No. 18-03-M-00148L and COC No. 18-03-M-00149L) for its Units 3 and 4 Modular Gas Turbine Power Plant, respectively, located in Brgy. San Rafael, Calaca, Batangas. Each unit has a 25MW capacity and the said COC shall be both valid for five (5) years or until February 28, 2023.
