We disclose that today we received from the Department of Energy (DOE) a copy of the 2018 Amendment to Coal Operating Contract No. 5 executed by the DOE and Semirara Mining and Power Corporation (the "Corporation") amending the coal contract area of Coal Operating Contract No. 5 in order to optimize the development and production of coal resources in Semirara Island. Under said amendment, the Corporation relinquished coal blocks 294, 375, 377 and 16, and replaced with coal blocks 214, 215, 254 and 257 all located in Semirara Island. It also relinquished the areas in Caluya and Sibay, Antique.

The amendment provides, as follows:

"Section 1. Section 2.1 of COC No. 5, as amended, is hereby further amended to read as follows:

"Section 2.1 Coal Contract Area means at any time the area subject of this Contract and defined in conformity with the blocking system established in the Act consisting of thirteen coal blocks as determined by the DEPARTMENT to be available for coal operating contract identified as *Coal Block (CB) Nos.* 28-G-214, -215, -254, -255, -256, -257, -295, -296, -297, -335, -336, -337, and -376."
