This has reference to the Department of Energy (DOE) Order dated June 4, 2019 and its subsequent letter dated July 4, 2019 docketed as "In Re: Violation of Department Circular No. DC2012-05-0006 or Guidelines on the Accreditation of Coal Traders and Registration of Coal End-Users, Semirara Mining and Power Corporation (SMPC), Respondent, DOE-ERDB Case No. 2019-06-0010."

In our July 16, 2019 disclosure to the Commission and the Exchange, the DOE pursuant to its July 12, 2019 letter granted SMPC's request to hold in abeyance the implementation of its June 4, 2019 cease and desist order and suspension of Coal Trader Accreditation No. CT-208-12-0351(R), subject to certain conditions.

We further mentioned that SMPC will submit a rejoinder (dated July 16, 2019) to the DOE with a prayer to amend the conditions, which might limit SMPC's compliance to its commitment per DOE approved Work Program.

Today, we received from the DOE its August 5, 2019 letter granting SMPC's request and reconsider the conditions earlier imposed in its July 12, 2019 letter. The DOE stated that after it had reviewed and evaluated SMPC's request, the conditions in its July 12, 2019 letter are modified, as follows:

- a. the cease and desist order dated June 4, 2019 is held in abeyance pending final resolution of DOE-ERDB CASE NO. 2019-06-0010; and
- b. SMPC shall faithfully comply with all its commitments and obligations under Coal Trader Accreditation No. CT-208-12-0351(R).

We shall advise the Commission and the Exchange on further developments of this matter.
