On January 28, 2022, the Energy Regulatory Commission (ERC) posted on its official website a Decision pertaining to ERC Case Nos. 2021-063 SC & 2021-064 SC, In Re: Violation of Article V of ERC Resolution No. 10, Series of 2020, Sem-Calaca Power Corporation (SCPC) respondent.

In the said Decision, SCPC was fined P337,200.00 for allegedly exceeding the number of allowed unplanned outages by 5.24 days for Unit 1; and P3,975,600.00 for allegedly exceeding the number of allowed unplanned outages by 96.2 days for Unit 2.

While SCPC has not received a copy of the official resolution, it intends to appeal this Decision by filing a Motion for Reconsideration with the ERC.
