Thereafter, the Board proceeded to approve the Corporation's quarterly financial statements for the interim period ended March 31, 2012. Accordingly, it showed an unaudited consolidated Net Income After Tax of P1.73 billion from P1.69 billion in 2011 of same period. Consolidated EPS for the quarter is P4.86, registering 3% improvement from Q1 2011 EPS of P4.73. The net contribution to the bottom line by the coal segment and the power segment are P1.13 billion and P0.60 billion, respectively. On the overall, the increase was driven mainly by the better performance of the power segment due to higher energy generation and higher contracted energy under bilateral contracts. Coal segment financial result was flat as average price slightly dipped during the quarter even though volume sold is higher by 2% from same period last year. Also, cost of sales is higher due to higher cost of coal inventory at beginning of the year and increase in fuel cost.
